## Benefits included ...

### ... in Trip Cancellation Costs Insurance

- ✓ **Reimbursement of the relevant proportion of the charter costs** if the journey is abandoned. If the journey is abandoned after commencement, the proportion of the charter costs relating to the unused time is insured.
- ✓ **Zero-excess option**  
If requested, the excess can be reduced to zero on payment of an additional premium.
- ✓ **In case of the skipper being unavailable, we will reimburse the cost for the return transportation of the chartered yacht**
- ✓ **Terror attack as reason for trip cancellation**  
If a terror attack happens 30 days before departure within a radius of 100 km around the charter base or the place of handover of the yacht the trip can be cancelled.

### ... in bond insurance

- ✓ **The "Bond Insurance Plus"**  
If the deposit cover for your charter cruise is insufficient, you can buy Bond Insurance Plus to supplement your Charter Package. Bond Plus can also be taken out separately online before taking over the charteryacht.
- ✓ **Regatta risk fully insurable** (within the charter packages or Bond Insurance Plus)  
Losses which occur during a regatta or training for a regatta can be included upon extra charge.
- ✓ **Also insures the unjustified retention of the deposit in the event of damage**
- ✓ **No exclusion of underinsurance**

## Skipper's Liability Insurance

Skipper's liability insurance covers damage that is caused to third parties through the use of the chartered motor or sailing yacht and tender by the skipper and crew. Included in the insured risks are damage to other ships and to harbour or jetty installations. Damage arising from gross negligence on the chartered ship and not covered by the lessor's hull insurance is also included. Also included is cover for loss of charter revenue, confiscation, hotel and transport costs and financial loss.



## Trip Cancellation Costs Insurance

The insurance reimburses any contractually payable charter cancellation costs and outward and return journey costs arising from the non-availability of a non-commercial skipper or one or more crew members, or, if the journey is abandoned after commencement, any additionally incurred return journey costs and the relevant portion of the charter costs.



## Travel Abroad Health Insurance

In addition to costs of medical treatment, medication and admission to hospital, foreign travel health insurance reimburses any return ambulance transport to the home country or repatriation costs in case of death.



## Personal Accident Insurance

The accident insurance in our charter package provides cover in cases of death and invalidity, including a number of aspects that are not protected by general accident insurance. Skipper and crew are insured during private use of the chartered yacht, tenders and watersports equipment and for trips ashore of up to 48 hours.



## Bond Insurance

Bond Insurance refunds the bond deposited by you if the charterer withholds such bond following an event of loss.

  - Buy your charter insurance simply online at [pantaenius.com/charter](https://pantaenius.com/charter).
  - The insurance must be requested 30 days prior to the begin of your charter or within 21 days after you have signed the charter agreement; In the latter case until the takeover of your chartered yacht.
  - Ten individuals can be listed in each application for insurance, should you require insurance for further individuals, you will need to sign additional insurance packages.
- If, however, you do not require insurance for the remaining individuals, please let us know how many persons are taking part in the cruise in total.
- Complete the crew list carefully. Insurance is only valid for named crew members.
